SECTION 3: HAZARDS IDENTIFICATION

3.1 EMERGENCY OVERVIEW

Odor, Color, Grade: clear, pale yellow, sweet odor General Physical Form: Gas Aerosol Immediate health, physical, and environmental hazards: Extremely flammable liquid and vapor. SECTION 6: ACCIDENTAL RELEASE MEASURES
